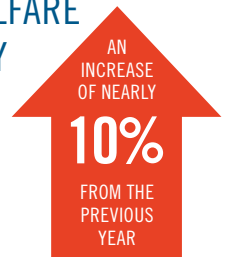

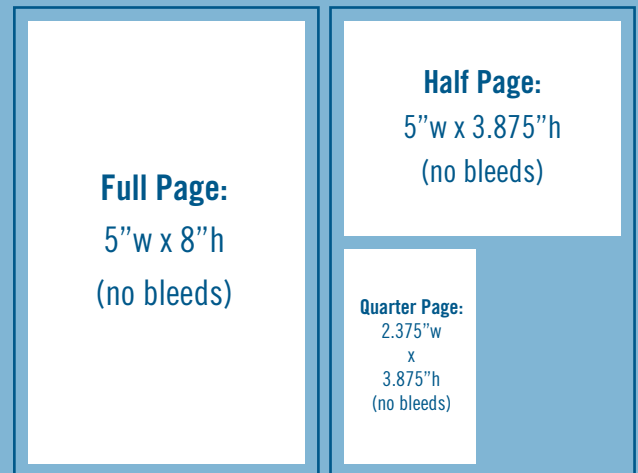

**FILE FORMATS:**

All ads are CMYK, RGB not acceptable

**PDF (Preferred Format)**

- PDF/X-1a
- PDF version must be 1.3 (Acrobat 4.0 compatible) and images CMYK (300dpi at 100% of final image size used)

**JPEG (Photoshop)**

- Ads MUST be CMYK and sized at 100% at 300dpi
